- 5. That the decedent died testate, having left a Will dated the 15th day of March, 1985, which was duly admitted to probate by Order of this Court entered on the 6th day of April, 1992, under the provisions of which EDWARD CORDA is the sole beneficiary of the decedent's estate.
- 6. The said estate has been administered according to law and is in condition to be distributed as provided in the Will of the decedent.
