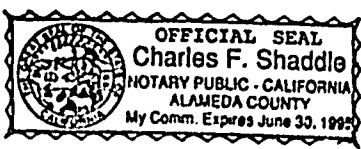

Parcel 2:

All that certain lot, piece or parcel of land situate in the County of Douglas, State of Nevada, more particularly described as follows, to-wit:

A piece of land 15 feet wide by 130 feet long, which is a part of Lot 6, Block B, adjoining the Northwesterly side of Lot 5, Block B, as delineated on that certain map entitled "Amended Map of Subdivision No. 2, Zephyr Cove Properties, Inc., in Sections 9 and 10, T. 13 N., R. 18 E., M.D.B.&M.," which was filed for record August 5, 1929, with Josephine L.
