

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

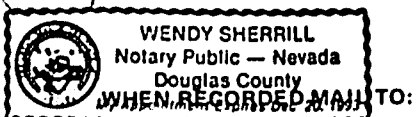
