1 4. ✓ That the defendant owes a duty of support to the
2 following dependents:

3 DANA DESIMONE Born: 11/21/87
4 JESSICA DESIMONE Born: 06/02/91

5 5. ✓ That the Defendant's Gross income is \$18,120.18 per
6 year. That in accordance with NRS 125B.070, Defendant
7 owes \$377.50 per month in ongoing child support.

8 6. ✓ That in the parties' divorce decree, defendant was
9 ordered to pay 25% of his gross income as ongoing
10 child support.

11 7. ✓ That the defendant owes child support arrears to
12 plaintiff in the amount of \$1,178.70 for the period
13 December 17, 1992 to and including March 16, 1993.

14 8. ✓ The Court further finds that the plaintiff did not
15 request enforcement of medical insurance.

16 THEREFORE, IT IS HEREBY ORDERED THAT:

17 1. ✓ That the defendant is the parent of the following
18 children:

21 2. ✓ Judgment is entered in favor of plaintiff and against
22 defendant in the amount of \$1,178.70 for the period
23 December 17, 1992, to and including March 16, 1993.

24 3. ✓ That defendant shall pay \$415.25 per month, by wage
25 withholding, to be paid as follows

29 4. ✓ The defendant shall provide health insurance coverage for
30 his minor children, if available at a reasonable cost
31 or at a reasonable cost through his employment.

32 5. ✓ The defendant shall notify the Douglas County District
33 Attorney's Office of any change in home address, mailing
34 address, telephone number, or employment, within ten
35 days of any change.

36 6. ✓ It is further ordered that:

37 (1) Defendant's first monthly child support
38 obligation shall be due on the 31st day of March,

1 1993, and shall continue due on the last day of each
2 and every month thereafter until further order of
3 this court.

4 (2) That when defendant's minor child(ren)
5 emancipate(s), defendant shall continue to pay
6 \$377.50 per month toward satisfaction of then
7 existing child support arrears in accordance with
8 NRS 125B.100.

9 (3) That defendant's ordered monthly payment on
10 child support arrearages does not preclude other
11 methods of collection for child support arrears.

12 (4) This support order shall be reviewed every
13 three years in accordance with NRS 125B.145.

14 (5) That defendant's monthly child
15 support payments shall be in the form of a
16 cashier's check, certified check, or money order,
17 or in cash. If the payment is in the form of cash,
18 it must be delivered to the Douglas County Clerk at
19 her office in Minden, Nevada. If the payment is in
20 the form of a cashier's check, certified check, or
21 money order, it must be made payable to the
22 DOUGLAS COUNTY CLERK, must contain the notation
23 Case No. 920298 (DeSIMONE), and be either mailed
24 to the Douglas County Clerk at Post Office Box
25 218, Minden, Nevada 89423, or delivered to said
26 County Clerk at her office in Minden,
27 Nevada. The Douglas County Clerk shall
28 transmit said payments to: ROBYN DeSIMONE.

7. X NOTICE: This is an income withholding order. Support
payments in arrears by 30 days may be withheld from income
without further order of any court or further application
for services.
