This Court has reviewed plaintiff's Application for Default and all pleadings and papers on file herein, and makes this order by way of default.

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

That the Court has jurisdiction of the parties and subject matter of this case.

That the defendant was personally served with the Notice of Finding of Financial Responsibility on March 3, 1993.

That the defendant is the parent of the following child: EMMA LOUISE NOYES Born: 08/07/86.

That the defendant owes a duty of support to the following child: EMMA LOUISE NOYES Born: 08/07/86.

That \$329.97 per month is a reasonable amount of ongoing child support for defendant to pay, in accordance with NRS 125B.070 and the Nevada Average Wage Guide for the reason that the Defendant is self-employed.

That the defendant owes child support arrears in the amount of \$3,199.70 for the period September 1992 through and including April 6, 1993.

3 That the defendant is the parent of the following

arrears for the period September 1992 through and including
April 6, 1993.

12 Attorney's Office of any change in home address, mailing address,
13 telephone number, or employment, within ten days of any change.

14 IT IS FURTHER ORDERED THAT:

15 Defendant's first monthly child support
16 obligation shall be due on the first day of May,
1993, and shall continue due on the first day of
each and every month thereafter until further order
of this court.

17 That when defendant's minor child(ren)
18 emancipate(s), defendant shall continue to pay
\$329.97 per month toward satisfaction of then
19 existing child support arrears in accordance with
NRS 125B.100.

20 That defendant's ordered monthly payment on
child support arrears does not preclude other
21 methods of collection for child support arrears.

22 This support order shall be reviewed every
three years in accordance with NRS 125B.145.

23 That defendant's monthly child support
24 payments shall be in the form of a cashier's
check, certified check, or money order, or in
25 cash. If the payment is in the form of cash, it
must be delivered to the Douglas County Clerk at
26 her office in Minden, Nevada. If the payment is in
the form of a cashier's check, certified check, or
27 money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
Case No. 930027 (OSMAN), and be either mailed to
28 the Douglas County Clerk at Post Office Box
218, Minden, Nevada 89423, or delivered to said
County Clerk at her office in Minden, Nevada.
