STIPULATION

GEORGE WALTER ABBOTT JR.,

IT IS HEREBY AGREED between plaintiff ROBIN LYNN ABBOTT, by and through her undersigned legal counsel, and defendant GEORGE WALTER ABBOTT JR., that this court may enter an order in accordance with the terms of this stipulation.

1. Defendant and plaintiff agree and understand that in an Order filed March 16, 1993 in the Ninth Judicial District of the State of Nevada, County of Douglas, defendant was ordered to pay the sum of \$270.00 per month as ongoing support of his minor children, JORDAN MARY ABBOTT Born: 07/26/88; and HAYLEY JEANNE ABBOTT Born: 04/29/91.

2. Defendant and plaintiff agree and understand that, in the above-mentioned order, judgment was entered in favor and

1 plaintiff and against defendant in the amount of \$850.00 for  
2 child support arrears.

3  
4 3. Defendant and plaintiff agree and understand that  
5 defendant owes \$850.00 in child support arrearages through and  
6 including March 1993.

7  
8 4. Defendant and plaintiff agree that this Court may  
9 enter an order requiring defendant to pay \$270.00 per month as  
10 ongoing support, plus \$30.00 per month toward satisfaction of  
11 child support arrears for a total of \$300.00 per month.  
12 Defendant and plaintiff agree that defendant's first \$270.00  
13 monthly payment shall be due on April 1, 1993, and continue due  
14 on the first day of each and every month thereafter until  
15 further order of this court.

16  
17 5. Defendant understands that his child support  
18 payments shall be made by wage withholding.

19  
20 6. Defendant and plaintiff agree and understand that  
21 the plaintiff did not request medical support enforcement  
22 services.

23  
24 7. Defendant understands that, in the event he  
25 becomes unemployed, all child support payments to be made by  
26 him to plaintiff must be in the form of a cashier's check,  
27 certified check, or money order, or in cash. The defendant  
28 further understands that if the payment is in the form of cash

1 it must be delivered to the Douglas County Clerk at her office  
2 in Minden, Nevada. If the payment is in the form of a cashier's  
3 check, certified check, or money order, Defendant understands  
4 that it must be made payable to the DOUGLAS COUNTY CLERK, with  
5 the notation Case No. 930071 (GEORGE WALTER ABBOTT JR.), and be  
6 either mailed to the Douglas County Clerk at Post Office Box  
7 218, Minden, Nevada 89423, or delivered to said County Clerk at  
8 her office in Minden, Nevada. The Douglas County Clerk shall  
9 transmit said payments to: ROBIN L. ABBOTT.

11 8. Defendant agrees that this court may enter an  
12 order requiring defendant to notify the Douglas County District  
13 Attorney's Office in writing within 10 days of any change in  
14 defendant's mailing address, home address, or employment.


16 9. Defendant understands that this support order may
