18 Attorney's Office of any change in home address, mailing
address, telephone number, or employment, within ten days of any
change.

19 **IT IS FURTHER ORDERED THAT:**

20 Defendant's first monthly child support
21 obligation shall be due on the first day of May,
22 1993, and shall continue due on the first day of
each and every month thereafter until further order
of this court.

23 That defendant's ordered monthly payment on
24 child support arrearages does not preclude other
methods of collection for child support arrears.

25 That defendant's monthly child support
26 payments shall be in the form of a cashier's
27 check, certified check, or money order, or in
28 cash. If the payment is in the form of cash, it
must be delivered to the Douglas County Clerk at
her office in Minden, Nevada. If the payment is in

1 the form of a cashier's check, certified check, or
2 money order, it must be made payable to the
3 DOUGLAS COUNTY CLERK, must contain the notation
4 Case No. 920020 (SCOTT), and be either mailed to
5 the Douglas County Clerk at Post Office Box
6 218, Minden, Nevada 89423, or delivered to said
7 County Clerk at her office in Minden, Nevada.
8 The Douglas County Clerk shall transmit said
9 payments to: Nevada State Welfare Division.

10 **OBJECTIONS TO THIS ORDER MAY BE FILED WITH THE**
11 **DISTRICT COURT AND SERVED UPON THE OTHER PARTY WITHIN TEN (10)**
12 **DAYS OF RECEIPT OF THE CHILD SUPPORT HEARING MASTER'S**
13 **RECOMMENDATIONS.**

22 **MASTER'S RECOMMENDATIONS AND ENTERS JUDGMENT ACCORDINGLY.**


