

NOTICE OF DEFAULT AND ELECTION TO SELL

NOTICE IS HEREBY GIVEN THAT:

CHRISTOPHER MARSH and CATHERINE REID, hereinafter referred to as "Debtor", of 44 SHERIE DR., CANADA, L4P 3R2, is indebted to World Class Resorts International, Inc., hereinafter referred to as "Club", a Nevada Not For Profit Corporation, in the amount of \$321.70 which represents the balance owing for non-payment of duly levied annual dues and/or other assessments on a certain membership in "Club", as described herein. If this membership has been pledged as security for a financing contract, the "debtor" may still be obligated to satisfy that obligation.

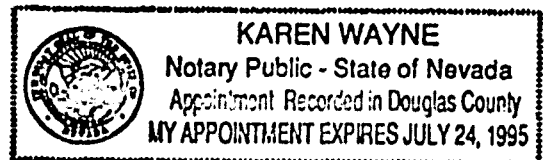
