

NOTICE OF DEFAULT AND ELECTION TO SELL

NOTICE IS HEREBY GIVEN THAT:

If this membership has been pledged as security for a financing contract, the "debtor" may still be obligated to satisfy that obligation.

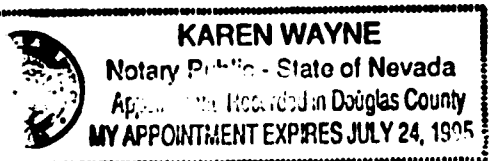
