

SUBSTITUTION OF TRUSTEE


WHEREAS, on September 5, 1987, Shirley M. Lane and Doris A. Lane, husband and wife as joint tenants with right of survivorship executed that certain deed of trust dated September 5, 1987 to Douglas County Title Company, now known as Stewart Title of Douglas County, a corporation as trustee ("Initial Trustee") for the benefit of SAIDA of Nevada, Inc., beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on September 22, 1987 in Book 987 at Page 3446 as Document Number 162743 (the "Deed of Trust"); and



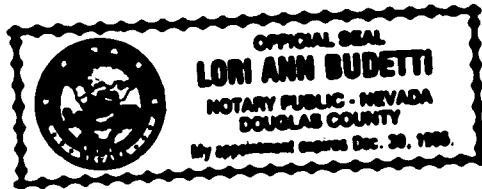
