

SUBSTITUTION OF TRUSTEE


WHEREAS, on September 2, 1985, James W. Linhart and Mary V. 

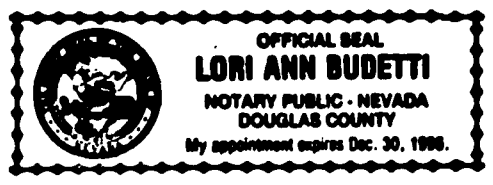
