

SUBSTITUTION OF TRUSTEE


WHEREAS, on September 22, 1985, Steven G. Loup and Kathleen M. Loup, husband and wife as joint tenants with right of survivorship executed that certain deed of trust dated September 22, 1985 to Douglas County Title Company, a corporation as trustee ("Initial Trustee") for the benefit of SAIDA of Nevada, Inc., beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on October 8, 1985 in Book 1085 at Page 808 as Document Number 124925 (the "Deed of Trust"); and
