# POWER OF ATTORNEY

## SPECIAL

KNOW ALL MEN BY THESE PRESENTS: That I, Omohundro Company, a California corporation, the undersigned (jointly and severally if more than one, hereinafter collectively "principal"), hereby make, constitute and appoint Douglas P. Rastello

principal's true and lawful attorney to act for principal and in principal's name, place and stead and for principal's use and benefit:

(a) To execute any and all documents that such attorney, in his sole and absolute discretion, shall deem to be necessary or appropriate with respect to a loan, credit facility, revolving loan, term loan or any other banking relationship whatsoever by FIRST INTERSTATE BANK OF NEVADA, N.A.
