- (X) An arrears Judgment is entered in the amount of \$4628 through June 1993.
- (X) The Defendant shall pay \$ 334 per month in ongoing support beginning June 30, 1993.

All payments MUST be made in the form of a cashier's check or money order ONLY, and shall be made payable to DOUGLAS COUNTY CLERK, and mailed to P.O. Box 218, Minden, Nevada 89423.

NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO THE PETITIONER.

Additionally, the Defendant MUST place the District Attorney's case number 930126 on each payment.

6. The defendant shall provide health insurance coverage for the child(ren) when available through employer/group insurance and provide assistance in obtaining payment for insured services.
7. The parties shall split the cost of any uncovered medical expenses.
8. The defendant shall pay and judgment is entered in favor of the plaintiff for the cost of paternity testing totalling \$_____.
 - A. To be paid by payments once the arrearage judgment is paid in full.
 - B. To be paid in full within thirty (30) days.
9. The Defendant shall notify the Douglas County District Attorney's Office of any change of address or employment within 10 days.
10. The Defendant shall complete and return the vital statistics form (provided to him in open court this date) to the Support Division within ten days of this recommendation.
11. A wage withholding shall be issued immediately.
 - Good cause being found by the Court: _____

_____ said wage withholding shall be postponed until such time as the defendant becomes 30 days delinquent under this Order.

 - Defendant shall be responsible for the first child support and judgment payments due. Payment is to be made directly to the DOUGLAS COUNTY CLERK (see address, above).
 - The parties agree in writing that a wage withholding shall not be issued until defendant becomes 30 days delinquent under this Order.
12. A financial review shall be held: _____.

13. (X) Custody of the minor children will remain with the Plaintiff until such time as a custody hearing is requested and held.
14. Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject to future modifications.
15. Unless a stay of this Order is obtained from District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and the attachment of federal income tax returns will be undertaken upon entry of this Order.
