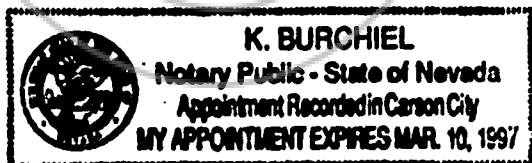

RIDGE CREST LEGAL

An Alternate Timeshare estate comprised of:
