As more particularly described in Exhibit "A" attached hereto and by this reference made a part hereof.

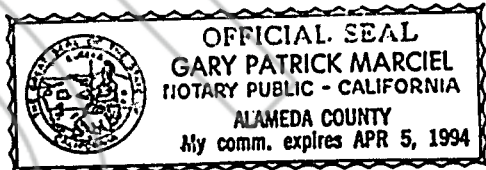
