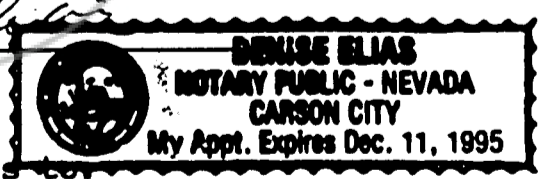

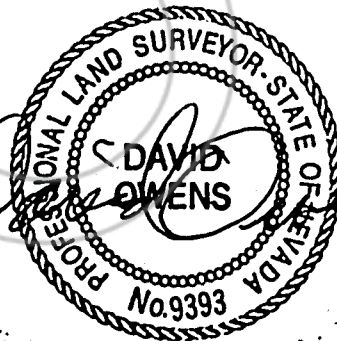
EXHIBIT A
