The proposed course or direction of the tunnel is 20° EAST OF MAGNETIC NORTH, APPROXIMATELY 3300 FT. EAST OF THE WEST AREA ON THE NORTH SIDE OF THE HIGHWAY 50 FENCE, AND RUNNING 1200 FT. IN THE SE 1/4 OF THE NE 1/4 OF SEC 6, T. 14N, R. 19E.

The proposed height of the tunnel is 8 feet, and the proposed width of the tunnel is 8 feet.

The position and number of each ~~boundary~~ CENTER LINE monument of this tunnel right is shown on the tunnel right map that is filed herewith. Note 1: Two copies of this certificate and two copies of the tunnel right map must be filed, and the \$15 filing fee must be paid, within 90 days after date of posting the Notice of Location.

Note 2: "The locator of a tunnel right or location shall record his location with the county recorder . . . which must be similar in all respects to the notice posted on the location." NRS 517.170, Subsection 1. It is suggested that this form be used as a tunnel right Notice of Location, with the word Certificate crossed out and Notice written in.

Note 3: "Every person who willfully and knowingly makes a false material statement on the location certificate or on any map required by this chapter shall be guilty of a felony, and upon conviction thereof shall be imprisoned in the state prison for not less than 3 years nor more than 10 years." NRS 517.300, Subsection 2.
