17 In this action the Defendants JOBS PEAK CONSTRUCTION, INC. having been served
18 with Summons and Complaint on February 24, 1993 and TONY L. HUDSON, having been
19 served with Summons by publication, and Proof of Service having been filed herein, and the
20 legal time for answering having expired, and no Answer having been filed by said Defendants,
21 the Defaults of said Defendants having been duly entered according to law; upon application
22 of Plaintiff, Judgment is hereby entered for Plaintiff against said Defendants, JOBS PEAK
23 CONSTRUCTION, INC. and TONY L. HUDSON, pursuant to the prayer of said Complaint.
