

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 7, 1991, Sandra L. 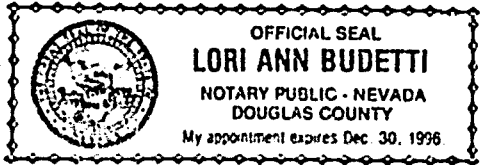

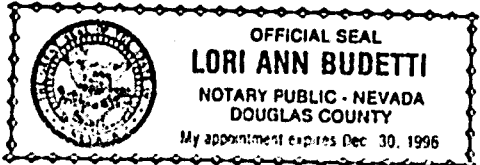
