

CERTIFICATION OF DECLARATION

I, Bernie Costello, living in Lyons County, Nevada, do hereby make the following declaration of status:

1. I am a native born American de jure citizen sui juris, white male, sovereign, bona fide, domestic, State citizen de jure. I live within the boundaries of the Nevada state, Douglas County, (unattached by the 14th amendment) a sovereign county within Nevada, one of the several States of the Union of States. I am the posterity and trace generations of my parents and grandparents, all American de jure citizens sui juris, prior to 1868.

I declare and affirm that I am a State citizen pursuant to this public record declaration presented. I reject any foreign corporation such as the corporate federal United States claiming that I am one of its citizens. Rights exist by being a State citizen, not National citizenship. (Tribe, p. 1798) as in the Slaughterhouse Cases (1873) and Meyer v. Nebraska (1923). United States Citizens have only privileges and immunities, (14th amendment).

Being that one cannot be two "of's" i.e. citizen of the United States and citizens of the state, (see definition of "of" in Black's Law Dictionary, Sixth Edition), one must conclude that the real hard evidence as described on page three as my true status.

I declare and affirm that I am not a naturalized citizen of the Corporate federal United States or otherwise a statutory "citizen of the corporate federal United States, nor a resident alien, subject to the jurisdiction of the corporate federal United States," through an Act of Congress. I have never been naturalized, any claim of United States citizenship nexus was "SUBROSA". All the aforementioned facts concerning citizenship status causes one to conclude that they are non-immigrant, non-resident aliens to the corporate federal United States, and a state citizen to a State called Nevada and the several States.

2. I recognize the county sheriff to be the highest law officer in the state and any notices that affect me, presumed to have legal authority, must be served by that officer.

3. The kind of exclusion claimed in the amount of \$343,925.77 is based upon the following:

- a) No wages came from a trade or business conducted in the corporate federal United States,
- b) no income effectively connected with a corporate federal United States trade or business,
- c) no earned income from any corporate federal United States source, and
- d) earnings, exempt from United States tax under the fundamental law.

My citizenship status has never been judicially determined, therefore this public record declaration will confirm and enforce

my true status in all judicial courts, State and Federal, coupled with the UCC without prejudice 1-207 the remedy that removes me from all colorable consideration, colorable law, colorable courts (i.e. tribunals), colorable judges, colorable prosecutors and yes colorable jury's.

No alleged contracts or commercial agreements (i.e. privileges) ere entered knowingly, intentionally, or voluntarily. Being that I was induced in the Social Security Agreement "SUBROSA'", resulting in my trading of state privileges and immunities of corporate federal United States (statutory) citizenship. Consequently, United State citizenship, cannot be "IPSO FACTO'". Any attempt to enforce such alleged contracts or agreements would be deemed constructive fraud. Fraud vitiates a contract or agreement.

This public record declaration will serve as Prima Facie evidence if not rebutted by qualified authority. You have 30 days to reply, after that time, it becomes real evidence if no reply or rebuttal is received.


