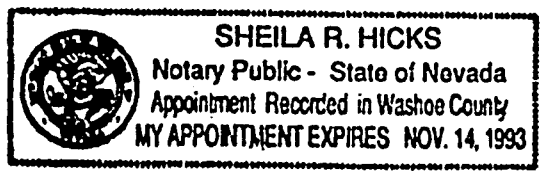

COMMENCING at the center of said Lot 30, being a circular lot with a radius of 35.00 feet; thence South 89°50'20" East, 35.00 feet to a point on the boundary of said Lot 30, said point being the TRUE POINT OF BEGINNING; thence along said boundary being a curve to the left having a tangent bearing of North 00°09'40" East and being concave to the Southwest through a central angle of 32°37'22" with a radius of 35.00 feet, an arc length of 19.93 feet to a point on the boundary of said lot which lies North 57°32'18" East, 35.00 feet from the center of said lot; thence leaving said boundary South 73°50'59" West, a distance of 67.18 feet to a point on the boundary of said Lot 30, which bears North 89°50'20" West, 35.00 feet from the center of said Lot 30; thence along said boundary being a curve to the left having a tangent bearing of South 00°09'40" West, and being concave to the Northeast through a central angle of 32°37'22" with a radius of 35.00 feet, an arc distance of 19.93 feet to a point, which bears South 57°32'18" West, 35.00 feet from the center of said Lot 30; thence leaving said boundary North 73°50'59" East, 67.18 feet to the POINT OF BEGINNING.
