

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 29, 1993, Kevin R. Meikle and Sandra L. 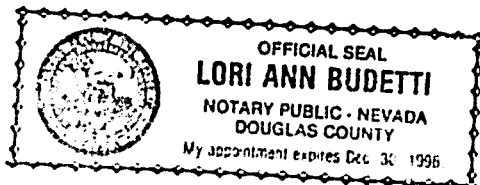

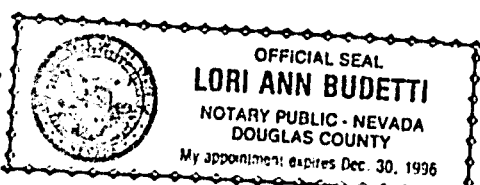
