

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 14, 1989, E. 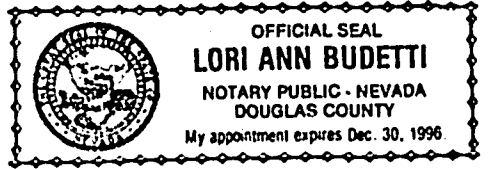
