

SUBSTITUTION OF TRUSTEE

WHEREAS, on August 5, 1990, E. William Henriod and Sharon D. 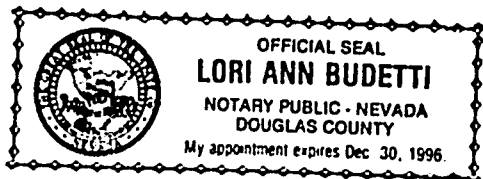

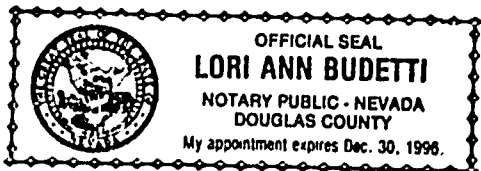
