in the official records of DOUGLAS County, Nevada.

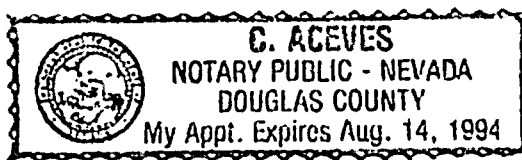
