That the First and Final Account of BANK OF AMERICA NEVADA, as Executor of the Last Will and Testament of ELSA BRAGG, deceased, be, and the same is, hereby finally settled, allowed, and approved, and all actions taken by the Executor in connection with the administration of the estate as set forth in the account and petition filed herein on October 5, 1993, are hereby ratified and approved.

5 closing costs and expenses in this estate matter:

7 publication of notice, certified copies of this order and other winding up expenses in connection with
8 closing this estate, not to exceed \$300.00.

9 (b) To JAMES M. O'REILLY attorney's fees in connection with services rendered to
10 this estate in the amount of \$ 4263.13.

11 4. That said Executor is hereby authorized and directed to pay itself a statutory commission
12 in the amount of \$4,263.13.

13 5. That said Executor is hereby authorized and directed to pay and distribute all the rest and
14 residue of the decedent's estate, together with any other property not now known or hereafter
15 discovered, to AILI DORE.

16 6. That the Court does hereby retain jurisdiction of the above-entitled estate until the same shall
17 be distributed and closed, and that upon said Executor filing a supplementary accounting showing
18 payment of all sums of money due from it, and that it has delivered up all the remaining property of
19 the estate to the beneficiary entitled thereto, that a decree of discharge shall be entered and filed
20 discharging said Executor from all liability thereafter to be incurred.
