

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 1st day of December, 1993, between

Donald R. Leverty and Kathleen J. Leverty, herein called TRUSTOR,

Donald R. Leverty, Inc. Nevada corporation, herein called TRUSTEE, and

Donald R. Leverty, Inc. herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property in APN # 15-060-45 County, Nevada, described as:

All that certain lot, piece or parcel of land situated in the County of Douglas, State of Nevada, described as follows:

A portion of the Southeast one quarter of Section 34, Township 14 North, Range 19 East, MDB & M., Douglas County, Nevada being more particularly described as follows:

Beginning at the intersection of the Easterly right-of-way line of Jacks Valley Road with the Southerly line of the Northwest one quarter of the Southeast one quarter of section 34; thence North 21°46'35" East, along said Easterly right-of-way line, 942.85 feet; thence at right angles to said Easterly right-of-way line, South 68°13'25" East, 640.55 feet; thence South 17°57'15" West, 912.86 feet to a fence on the Northerly line of the Adams property; thence North 70°07'03" West, along said fence line, 230.78 feet to a fence corner; thence North 17°57'15" East, and following.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the the sum of \$ 270,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:

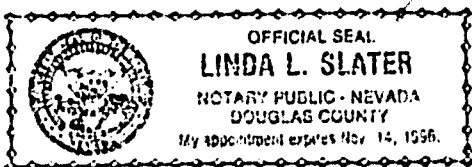
