FREDRIC CECIL STODIECK, Executor of the estate of WILLIAM HENRY ELVIN STODIECK, deceased, having heretofore rendered his First and Final Account and Petition for Fees and for Final Distribution of the above-entitled estate, said account and petition this day came on regularly to be heard.

The matter was submitted upon the verified petition and the record, the petitioner being represented by THEODORE H. STOKES, LTD. Proof having been made to the satisfaction of the Court that notice of settlement of said account and the hearing of said petition has been published and posted in the manner and for the time required by law, the Court finds:

1. Said account is in all respects true and correct.
2. Notice to Creditors was given in the manner and for the time required by law, and that seven (7) creditor's claims were filed against said estate. That said claims were inadvertently paid by the Executor.
3. The Court appointed FREDRIC CECIL STODIECK and he qualified as Executor of decedent's estate and performed all the duties of the Executor as required by law and is entitled to the

1 statutory fee for ordinary services rendered in the amount of
2 \$4,552.73.

3 4. THEODORE H. STOKES, LTD. served as attorney for the
4 Executor herein and pursuant to the Fee Agreement and affidavit
5 in support thereof on file herein is entitled to a fee of
6 \$8,800.00 for ordinary services rendered.

7 5. The said THEODORE H. STOKES, LTD. has incurred expenses
8 in the amount of \$174.20 for costs advanced in said estate
9 proceeding, in which amount said attorney is entitled to be
10 reimbursed.

11 6. That the Executor employed JOHN F. McDANIELS, JERRY
12 NEDDENRIEP and WILLIAM MENDES as independent appraisers in said
13 estate matter, and the Executor paid the said JOHN F. McDANIELS
14 the sum of \$1,000.00 for his appraisal. That JERRY NEDDENRIEP
15 and WILLIAM MENDES have waived their fees.

16 7. That BULLIS, MANKE and NELSON performed all services
17 required of them in the preparation of the federal estate tax
18 return and have been paid a fee by the Executor in the amount of
19 \$3,834.00.

20 8. That a federal estate tax return was prepared by BULLIS,
21 MANKE and NELSON and was filed August 9, 1982 on which \$18,654.86
22 was due to the Internal Revenue Service. Said sum has been paid
23 by Executor.

24 9. That the decedent left a Will dated the 14th day of
25 September, 1977, which was duly admitted to probate by Order of
26 the Court entered on the 8th day of October, 1982, under the
27 provisions of which FREDRIC CECIL STODIECK and KAYSIA STODIECK
28 BARR are the beneficiaries of said estate.

29 10. That the Executor duly inventoried all of the assets
30 of decedent's estate as required by law and filed his Inventory
31 and Appraisement thereof showing a gross estate of a value of
32 \$221,636.25.

1 11. That the monies received on behalf of decedent's
2 estate by the Executor and the disbursements of estate funds made
3 by the Executor are set forth in Exhibit "A" attached to the
4 Executor's First and Final Account and Petition for Fees and
5 Final Distribution on file herein.

6 12. That said estate has been administered according with
7 law and is in condition to be distributed as provided in the Will
8 of decedent.

9 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that:

10 A. The First and Final Account of said Executor be, and
11 the same is, hereby finally settled, allowed and approved.

12 B. The sum of \$8,800.00 is approved for THEODORE H. STOKES,
13 LTD., attorney for the Executor, as a reasonable fee for ordinary
14 services rendered as attorney for the Executor pursuant to the
15 Fee Agreement on file herein.

16 C. The sum of \$174.20 is allowed to THEODORE H. STOKES, LTD.
17 for reimbursement of costs advanced.

18 D. The said Executor is authorized to pay himself the sum
19 of \$4,552.73 as and for the statutory fee to which he is entitled
20 as Executor of this estate.

21 E. The Executor is hereby authorized and directed to dis-
22 tribute to FREDRIC CECIL STODIECK and KAYSIA STODIECK BARR, all of
23 the rest, residue and remainder of said estate, as provided in the
24 Will of decedent.

25 F. After payment of all costs and fees as ordered herein
26 and distribution of the assets of said estate as herein ordered
27 and the filing of proper vouchers and receipts in support of
28 such payments and distribution, the Executor is authorized to file
29 his Affidavit for Discharge from duties as Executor of this
30 estate. Upon completion of the foregoing matters and the filing

2 Letters Testamentary vacated.
