This Amendment, made and entered into this 31st day of December, 1992, between the State of Nevada, acting through its Department of Transportation, hereinafter referred to as STATE and the town of Gardnerville, political subdivision of the State of Nevada, hereinafter referred to as TOWN.

WITNESSETH:

Whereas, the parties hereto desire to make certain amendments pursuant to this Agreement;

Now, therefore, the parties agree as follows:

STATE AGREES

1. To reimburse TOWN for actual costs of the improvements but in no instance shall exceed \$67,100.00 as outlined in Exhibit "B" attached and made a part of this agreement. This is an increase of \$17,600.00.

TOWN AGREES

1. To invoice STATE for those project construction costs which are the responsibility of STATE, as specified in Exhibit "B".

The term of this Agreement shall be from the date first written above until December 31, 1994 and shall be renewable by written amendment to this agreement by the parties.

All other provisions of AGREEMENT No. P061-92-201 dated February 6, 1992 will remain unchanged.
