

SUBSTITUTION OF TRUSTEE

WHEREAS, on March 20, 1993, Thomas V. Tait and Donna H. 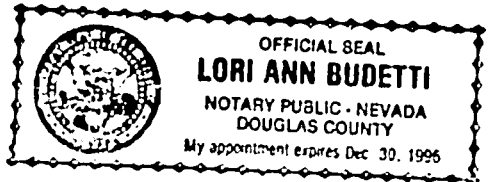
