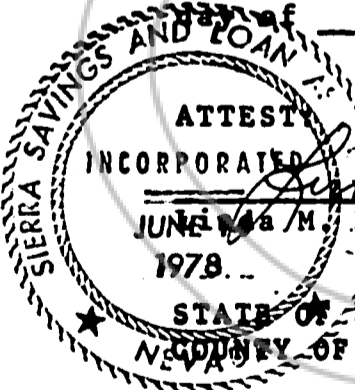
FOR VALUE RECEIVED the undersigned grants, assigns and transfers to: **ALLIED GROUP MORTGAGE COMPANY**
