FOR VALUE RECEIVED, the undersigned grants, assigns and transfers to: **ALLIED GROUP MORTGAGE COMPANY**

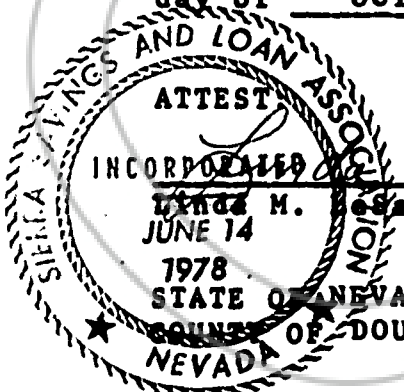
