

NOTICE OF DEFAULT AND ELECTION TO SELL

NOTICE IS HEREBY GIVEN THAT:

ROBERT M STENGELE and TONI DENISE STENGELE, hereinafter referred to as "Debtor", of 141 CEDARCREST LANE, LEWISVILLE, TX 750678438, is indebted to World Class Resorts International, Inc., hereinafter referred to as "Club", a Nevada Not For Profit Corporation, in the amount of \$309.60 which represents the balance owing for nonpayment of duly levied annual dues and/or other assessments on a certain membership in "Club", as described herein. If this membership has been pledged as security for a financing contract, the "debtor" may still be obligated to satisfy that obligation.

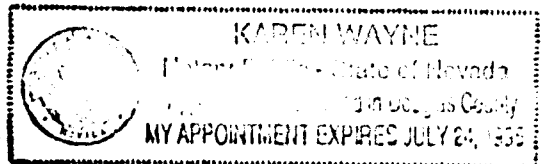
