

NOTICE OF DEFAULT AND ELECTION TO SELL

NOTICE IS HEREBY GIVEN THAT:

MILTON ROBERT LUMLEY and ANITA MARION LUMLEY, hereinafter referred to as "Debtor", of 2024 HUTTNER COURT, HOFFMAN ESTATES, IL 60194, is indebted to World Class Resorts International, Inc., hereinafter referred to as "Club", a Nevada Not For Profit Corporation, in the amount of \$182.70 which represents the balance owing for nonpayment of duly levied annual dues and/or other assessments on a certain membership in "Club", as described herein. If this membership has been pledged as security for a financing contract, the "debtor" may still be obligated to satisfy that obligation.

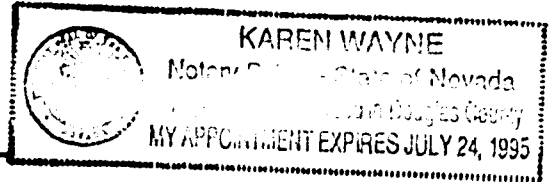
