That your affiant is the surviving spouse of said decedent and that said decedent died on the 18th day of March, 1994.

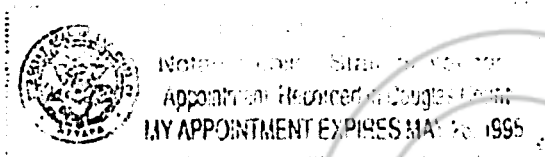
