

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 15, 1991, Grace M. 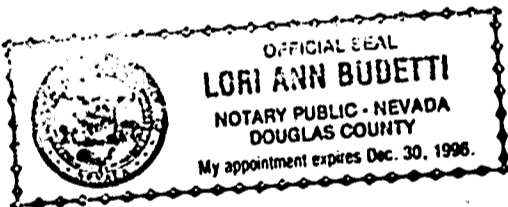

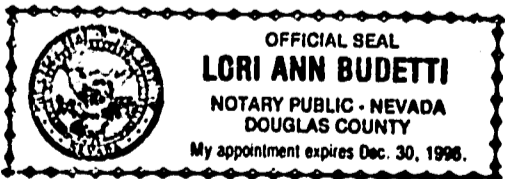
