13 This Court has reviewed plaintiff's Application for  
14 Default and all pleadings and papers on file herein, and makes  
15 this order by way of default.

16 Petitioner is represented by the Douglas County  
District Attorney's Office.

17 Respondent was duly served but failed to file an  
18 answer and did not request a conference with the District  
Attorney's Office, Child Support Division.

19 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

20 That the Court has jurisdiction of the parties and  
21 subject matter of this case.

22 That the defendant was personally served with the  
Notice of Intent to Enforce An Order on May 6, 1994.

23 That the defendant is the parent of the following  
24 child: DOUGLAS D. POPE Born: 06/17/80

25 That the defendant owes a duty of support to the  
following child: DOUGLAS D. POPE Born: 06/17/80

26 That \$216.67 per month is a reasonable amount of  
27 ongoing child support for defendant to pay in accordance with  
the parties divorce decree.

1 That the defendant owes child support arrears in the  
amount of \$24,350.00 through and including July 31, 1994.

2  
3 **THEREFORE, IT IS HEREBY ORDERED THAT:**

4 That the defendant is the parent of the following  
child: DOUGLAS D. POPE Born: 06/17/80

5 Judgment is entered in favor of plaintiff and against  
6 defendant in the amount of \$24,350.00 through and including  
July 31, 1994.

7 Defendant shall pay \$370.67 per month, by wage  
8 withholding, to be paid as follows:

9 PAYEE: DOUGLAS COUNTY CLERK	CHILD SUPPORT	\$216.67

11 The defendant will secure and maintain medical health  
12 insurance on the above named child when available through  
employment or other group policy. The Defendant is ordered to  
13 continue, upon the request of the Douglas County District  
Attorney's Office, to provide it with information regarding the  
14 availability of health insurance.

15 The defendant shall notify the Douglas County District  
Attorney's Office of any change in home address, mailing address,  
16 telephone number, employment, or medical insurance availability  
within ten days of any change.

17 **IT IS FURTHER ORDERED THAT:**

18 Defendant's first monthly child support  
19 obligation shall be due on the first day of  
August, 1994, and shall continue due on the first  
20 day of each and every month thereafter until further  
order of this court.

21 That when defendant's minor child(ren)  
emancipate(s), defendant shall continue to pay  
22 \$216.67 per month toward satisfaction of then  
existing child support arrears in accordance with  
NRS 125B.100.

23 That defendant's ordered monthly payment on  
child support arrearages does not preclude other  
24 methods of collection for child support arrears.

25 This support order shall be reviewed every  
three years in accordance with NRS 125B.145.

26 That defendant's monthly child support  
payments shall be in the form of a cashier's  
27 check, certified check, or money order, or in  
cash. If the payment is in the form of cash, it  
28 must be delivered to the Douglas County Clerk at  
her office in Minden, Nevada. If the payment is in

1 the form of a cashier's check, certified check, or  
2 money order, it must be made payable to the  
3 DOUGLAS COUNTY CLERK, must contain the notation  
4 Case No. 940085 (POPE), and be either mailed to  
5 the Douglas County Clerk at Post Office Box  
6 1240, Minden, Nevada 89423, or delivered to  
7 said County Clerk at her office in the Minden  
8 Inn, 1594 Esmeralda Avenue, Suite 105, Minden,  
9 Nevada. The Douglas County Clerk shall  
10 transmit said payments to: the State of Florida.
