AGREEMENT

THIS INDENTURE MADE THIS 12 day of July, 1994,
between the Edna Wilslef Ditch Association, Party of the First Part, hereinafter called
GRANTOR, and the County of Douglas, a political subdivision of the State of Nevada,
Party of the Second Part, hereinafter called GRANTEE,

WITNESSETH

That the GRANTOR, for and in consideration of the sum of ONE DOLLAR
(\$1.00), lawful money of the United States of America, and other good and valuable
considerations, the receipt whereof is hereby acknowledged, does by these presents, grant,
bargain, and sell unto the GRANTEE and to his assigns forever, a perpetual right to direct
storm runoff from Sagebrush Court into the Edna Wilslef Ditch at Kerry Lane as shown
on the construction plans for the Douglas County Paving Projects, Contract Number
94-07-01.

The parties further agree, as part of the consideration of this Agreement, that the
GRANTEE shall:

1. Monitor the effects of the new improvements on the existing ditch facilities.
2. Repair any damage to the downstream ditch system which occurs as a direct
result of the new improvements, and
3. Correct any deficiencies in the improvements to eliminate future damage to the
existing downstream ditch facilities as a result of the improvements.
