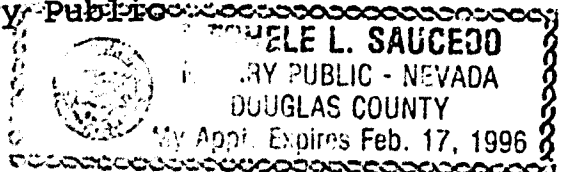

Legal Description
