secured by Deed of Trust executed by the makers of said note , wherein,

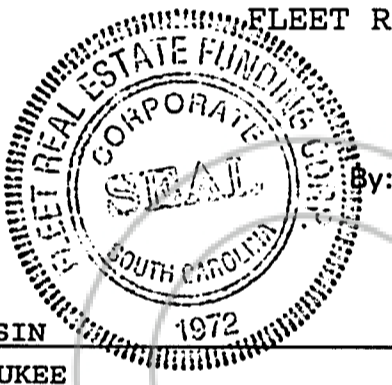

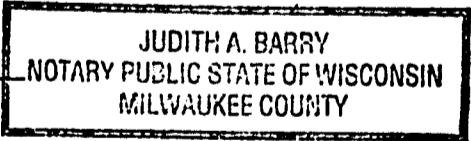
