ORDER APPOINTING SPECIAL
ADMINISTRATOR WITH FULL
POWERS OF GENERAL
ADMINISTRATION AND FOR
ISSUANCE OF SPECIAL
LETTERS OF
ADMINISTRATION

The Petition of MARGUERITE M. VANCE praying for the admission to probate of a certain instrument in writing filed with the Court on July 13, 1994, praying for Issuance of Letters Testamentary in the above-entitled proceeding, came on regularly for hearing this day; HELEN HARDY MILLS having filed her Contest and Objection to Probate of Will and Appointment of Executrix and she having appeared to contest the Petition; the Court now finds as follows:

I

That all notices of the hearing have been duly given as required by law.

II

That the decedent died on or about the 7th day of July, 1994, in the City of Reno, County of Washoe, State of Nevada, and

1 that decedent, at the time of his death, was a resident of
2 Glenbrook, Douglas County, State of Nevada, and left an estate in
3 the State of Nevada subject to administration.

5 That decedent left a document purported to be the Last
6 Will and Testament, dated April 15, 1994; and that said document
7 has been heretofore filed with the Clerk of this Court.

8 IV

9 That decedent's daughter, HELEN HARDY MILLS, filed a
10 Contest and Objection to Probate of Will and Appointment of
11 Executrix.

12 V

13 That the character and estimated value of the estate
14 subject to administration in Nevada consists of real and personal
15 property exceeding ONE HUNDRED THOUSAND DOLLARS (\$100,000.00).

16 VI

17 That there are debts of the decedent which must be paid
18 and estate matters to be handled and the parties have agreed that
19 FIRST INTERSTATE BANK OF NEVADA, N.A., should be appointed as the
20 Special Administrator of the estate with full powers of general
21 administration until the will contest and objection to probate are
22 resolved by this Court.

23 NOW, THEREFORE, the Court orders as follows:

24 That FIRST INTERSTATE BANK OF NEVADA, N.A., is appointed
25 Special Administrator of the estate subject to probate in the State
26 of Nevada with full powers of general administration, and that
27 Special Letters of Administration be issued to it upon the taking
