1. Notice of the Hearing of the Petition has been regularly given as prescribed by law.

2. All acts and transactions of the Executor of the Estate of Helen Elizabeth Cooney, Deceased, during the period of the account are accurately shown and should be approved, and all of the allegations of the Petition are true. The Account is complete and

correct and should be approved as filed.

3. Helen Elizabeth Cooney died testate on January 28, 1993, in Reno, Nevada, and was at the time of death a resident of Washoe County, Nevada.

- 4. On February 3, 1994, Donald G. Cooney was appointed Executor of the Decedent's estate and qualified as such on that date. Donald G. Cooney has been the Executor of the Decedent's estate since that time.
- 5. Notice to creditors (Summary Administration) has been given as required by law, the time for filing or presenting claims has expired, and the estate is now in a condition to be closed. No claims have been filed or presented against the estate. All debts of the Decedent and of the estate, and all expenses of administration, except for attorneys' fees and costs and closing expenses, have been paid.
- 6. Neither a federal estate tax return nor a federal fiduciary income tax return is required for the estate.
- 7. Petitioner has waived the statutory executor's commission which may be due in accordance with NRS 150.020.
- 8. Distribution of the assets of the estate should be ordered as specified below.

BASED UPON THE FOREGOING, the Court hereby orders the following:

- A. The administration of the Estate of Helen Elizabeth Cooney, is settled, allowed and approved as filed, without any further accounting.
- B. The First and Final Account of the Executor is settled, allowed and approved as filed.
- C. All acts and transactions of the Executor as disclosed in the First and Final Account are confirmed and approved.

D. The residue of the Decedent's estate, including any assets of the estate not now known or discovered that may belong to the estate or in which the Decedent or the estate may have an interest, shall be distributed to Donald George Cooney, as Trustee under The Donald George Cooney Family Trust Agreement dated September 18, 1974. Such assets include the undivided 1/15th tenants in common interest in the real property situated in the County of Douglas, State of Nevada, described as follows:

## Parcel 1:

Lot 11, Block F of ZEPHYR COVE PROPERTIES in Section 10, Township 13 North, Range 18 East, according to the official map thereof, filed in the Office of the County Recorder of Douglas County, State of Nevada, on August 5, 1926.

## Parcel 2:

All that portion of Lot 10, in Block F, West of a line parallel to and distant 37.5 feet perpendicular easterly from the boundary line and its extension common to Lots 10 and 11 in Block F as said Lots are set forth on that certain amended map of ZEPHYR COVE PROPERTIES in Section 10, Township 13 North, Range 18 East, M.D.B.&M., approved by the Board of County Commissioners of Douglas County, Nevada, August 5, 1929, and filed on said 5th day of August, 1929, in the office of the County Recorder, Douglas County, State of Nevada.

E. The property shall be held, administered, and distributed pursuant to The Donald George Cooney Family Trust Agreement dated September 18, 1974, and neither the trust nor any property added to the trust pursuant to the provisions of this Order shall be subject
