

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 3, 1993, Michael A. 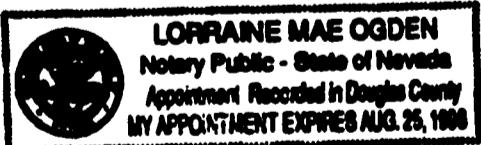
