The court finds that the decedent died on or about March 23, 1980 and at the time of his death he was a resident of the State of California and was married to the petitioner, MARGARET E. SLAYMAKER. That at the time of his death, the decedent and his spouse each were seised of an undivided one-half interest in certain real property situate within the County of Douglas, State of Nevada, which has a value of less than \$10,000.

That the decedent and petitioner intermarried on May 9, 1970. That the decedent left a Will dated February 13, 1970 which is on file with the Clerk of the Superior Court in and for the County of Alameda, State of California and that said Will was admitted to probate by that court on the 19th day of June, 1980 in Case No. 214813-7.

The court finds that the estate should be set aside without administration, in accordance with MRS 146.070, and in

accordance with decedent's Will, but in accordance with NRS 133.110 the Will is revoked with respect to the decedent's spouse as she is not mentioned in the Will and in that the decedent left two children as well as a spouse, she be entitled to take her intestate share of the decedent's estate or a 1/3 of his 1/2 interest or, namely, a 1/6 undivided interest in the real property owned within the State of Nevada by the decedent. That the remaining 2/3 interest or an undivided 1/3 interest in the property should pass to the devisees in the decedent's Will and as follows:

The court further finds that the petitioner be ordered to 21 pay her attorney the agreed fee of \$350 for services rendered and as well to reimburse him the sum of \$ 71.80 for filing fees and certified mailings as required by law.
