

SUBSTITUTION OF TRUSTEE

WHEREAS, on August 27, 1990, Jodi L. 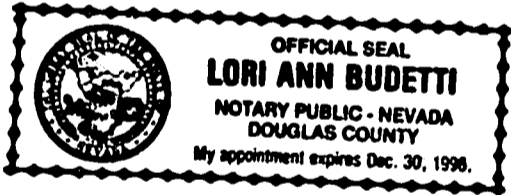
