

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 2, 1990, Michael P. 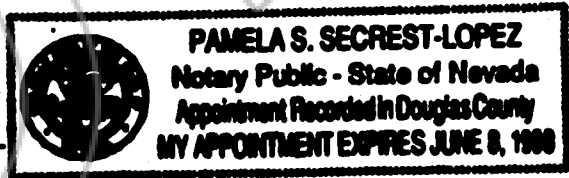

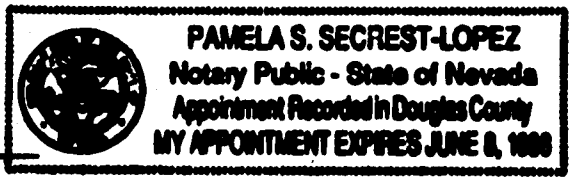
