

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 28, 1990, David L. Link and Elen M. 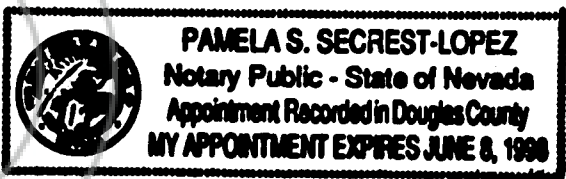

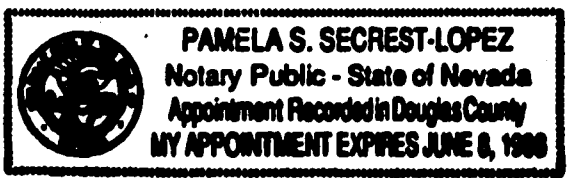
