## ABANDONMENT:

AN ORDER OF ABANDONMENT VACATING A PORTION OF TOWNSEND WAY, REDUCING A ONE HUNDRED FOOT ROAD RIGHT-OF-WAY, AS LOCATED WITHIN THE EAST VALLEY RURAL COMMUNITY

WHEREAS Douglas County, a political subdivision of the State of Nevada, presently holds an easement interest within the Section 14, Township 13 North, Range 20 East, MDB&M, for portions of that certain road right-of-way commonly known as Townsend Road. Said easement is more described below; and,

WHEREAS Douglas County, pursuant to the provisions of NRS 278.480 may vacate or abandon by formal order any portion of a public roadway which is in excess of its needs; and,

WHEREAS on November 30, 1993, the Douglas County Planning Commission held a public hearing in conformance with the provisions of NRS 278.240 to take testimony for said abandonment and did find that the reduction of this easement from a one hundred foot road right-of-way to a fifty foot road right-of-way would not have an adverse effect on the Douglas County Master Plan; and,

WHEREAS on December 16, 1993, the Board of Douglas County Commissioners held a public hearing to take testimony for said abandonment and did find that the one hundred foot road right-of-way is in excess of the needs of Douglas County.

NOW THEREFORE be it ordered by the Board of Douglas County Commissioners, that the right-of-way and incidents thereto, being all that land described as the west twenty-five feet (25') of the east fifty feet (50') of the northwest one-quarter of the northeast one-quarter of aforesaid Section 14; and, the east twenty-five feet (25') of the west fifty feet (50') of the northeast one-quarter of the northeast one-quarter of aforesaid Section 14, both as shown on the Division of Land for Nevis Industries Inc. as recorded February 2, 1979 in Book 279 at Page 124 as Document Number 29636 of the Official Records of Douglas County, Nevada, including that portion of the aforesaid easement as shown on the subsequent Parcel Map for Eldon Townsend (Document Number 146352) is hereby abandoned subject to the following conditions and stipulations:

- The subject easement shall revert to the abutting property owners as 1) prescribed within Chapter 278.480 of the Nevada Revised Statues.
- This abandonment is solely for the release of the public roadway 2) interest, and it is hereby confirmed that a Public Utility Easement embracing the limits of the original roadway is expressly reserved for the continuation, maintenance, expansion, and operation of the public utilities contained within the limits of this abandonment.
