

SUBSTITUTION OF TRUSTEE

WHEREAS, on June 18, 1994, Andrew Chavez and Irene C. 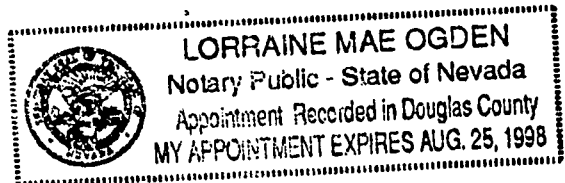
